Healing, Helping and Hoping

As we end the year and head into another, I would like to take this time to reflect on the three words we use to define Good News Clinics on the GNC logo: Healing, helping and hoping.

The GNC staff and medical volunteers spend their time at the Clinics healing many who are in need of medical and dental care. In the past fiscal year, our medical patient visits increased by more than 11 percent, and our physician volunteer hours increased by more than 20 percent. The amount of prescriptions filled also increased, and we continue to see a great need for our dental services, as well.

The Clinics help people of all ages and races-their only common bond is the need for healthcare. People such as a single mother of 2 who could not afford healthcare for herself and her children and told our staff of how GNC was there in her time of need and how she thanks God everyday for GNC. People such as a 49-year-old woman who'd lost her job, and her health insurance, due to company downsizing and was concerned because she was being treated for diabetes, asthma and hypertension and knew how critical ongoing medical care and medications were to her health. After being a patient at GNC for 10 months, she found a job with medical insurance and recently came in to make a donation to help other patients.

As far as hope, we hope that you will continue to support Good News Clinics in the year ahead. While the Clinics' income increased in 2008, so did the expenses. As you can imagine, in these increasingly tough economic times, we anticipate that the number of people who need the services of the Clinics will continue to grow in 2009, but with your generous support, Good News Clinics will be there to serve them in their time of need.

A United Way agency, GNC receive no government funding—we are able to provide our services at no charge due to the donations we receive from local businesses, churches, foundations and individuals, including our patients who give back to GNC to help others benefit from the Clinics' services.





Estimated Market Value of Services: Fiscal Year 10/1/07 – 9/30/08

Sam Poole Medical Clinic Medical Services:

Medical services include those services performed by volunteer medical doctors supported by volunteer staff and GNC paid staff plus clinic overhead. Total physician volunteer hours for FY2008 = 3,334 hours.

Value of Medical Services = \$2,160,000

Green Warren Dental Clinic Dental Services:

Dental services include those services performed by volunteer dentists and hygienists supported mostly by GNC paid staff and overhead. Total dentist volunteer hours for FY2008 = 1,404 hours.

Value of Dental Services = \$956,008

Dispensary Prescription Medications:

Prescription medications include samples supplied by physician offices, purchased medicines and donations from pharmaceutical companies.

Retail Value of Prescription Medications = \$3,750,236

External Medical Services:

External medical services include follow-up procedures performed by physician specialists in their offices or medical facilities, eyeglasses and Health Access Initiative services.

Value of External Medical Services

= \$2,972,284

= \$9,838,618
