## GNC Honors Founder of Green Warren Dental Clinic

On September 11th, Good News Clinics hosted a reception honoring longtime volunteer Dr. Ed Burnette. Dr. Burnette was the founder of the Green Warren Dental Clinic in 1997 and subsequently recruited 40 dentists to volunteer serving uninsured patients. He served as volunteer Dental Director for nearly 18 years before retiring in January 2014.

Funding for the Green Warren Dental Clinic was given by Anne Warren Thomas, who donated the money needed to buy equipment for the clinic. The dental clinic was named the Green Warren Dental Clinic in honor of Mrs. Thomas' father, a dentist in Atlanta.

During the reception, Dr. Burnette was honored with a commendation signed by Governor Nathan Deal and a proclamation issued by the Hall County Board of Commissioners recognizing his service. In addition, the four dental examination rooms at Good News Clinics were named in his honor. Under

Dr. Burnette's leadership, the Green Warren Dental Clinic has grown to become the largest free dental clinic in the state. Since its founding, the dental clinic has provided more than \$10 million in services to more than 18,000 uninsured, low-income residents of Hall County.
